- You must provide:**
- A road worthy vehicle – current vehicle registration and proof of insurance are required
 - \$11.50 Skills Tester Fee (**cash**) (\$17.50 effective January 1, 2010)
 - If over 17 - signed receipt from licensing office that shows \$3.50 skills test fee was paid (\$6.50 effective January 1, 2010)

 - If under 17 - properly completed SIP - signed off by parent/legal guardian
If you are in the GDL program and you skills test even one day before your eligibility date, you will have to repay the \$3.50 to the county and the \$11.50 to a skills tester (\$6.50 and \$17.50 starting January 1) and retake the skills test

 - Medical Skills Tester Evaluation Form** if the skills testing is due to a medical or visual condition

Basic vehicle control and driving skills are included in the skills test to determine your ability to handle normal and hazardous traffic situations. Vehicles with proximity sensors can be used for skills tests if the sensors can be turned off.

- You will be tested on:**
- Normal Stops
 - Intersections and Turns
 - Lane Changes
 - Parking Lot Driving
 - Street Parking
 - Freeway or Highway Driving

Notes:

- **Please be courteous when scheduling your appointment**
- **Do not call after 9 PM or before 8 AM**
- **Speak clearly and include your phone number when leaving a message**
- **Be sure to schedule with only one tester**
- **If you find a more convenient appointment than the one you first scheduled, be sure to cancel any other appointment(s) you have made with another tester(s)**

You are not required to test in the county where you reside.
